## Role Outline

Role title: **Worship Leader**

### *Part 1 – The Role*

**The Church takes the safety of everyone within the church very seriously and expects that everyone will work within the Church's safeguarding policy. In particular, the Church expects anyone who becomes aware of a safeguarding risk or of actual abuse, to immediately raise this with the Safeguarding Officer or the Minister\*.**

The following duties will be undertaken as part of the role outlined above:

- Worship leaders are called of God, to be worthy in character and to assist in leading God's people in worship.
- [Church] Sunday Worship Leader rota.
- To help lead worship with knowledge, conviction and competence and in accordance with our Methodist doctrines.
- Worship Leaders are welcome to attend the United Stockport Circuit of Worship and Preachers' Meeting.
- To continue to develop in knowledge, conviction and competence and to attend a class, house group or similar fellowship group if possible.
- It is the duty of worship leaders regularly to attend public worship at [Church] and to receive the Sacrament of the Lord's Supper.
- To share pastoral concerns with the clergy and/or leader/s
- To notify safeguarding issues to the Safeguarding Officer or Minister\*.
- On their appointed Sundays Worship Leaders should usually
  - contact the preacher for the day 1-2 weeks before the date of the service
  - offer to assist in the service as required
  - explain anything special that is taking place that Sunday
  - for preachers who have not visited the church before, to explain the location and layout of the church, the time of the service; the use of a sound system and projector; the practices of the church regarding children/Sunday Club, the usual use of the NRSV version of the Bible; offertory; communion distribution; the hymn books available.
  - request that hymns, PowerPoint presentations and anything else for the screen should be sent to the Worship Leader by the evening of the Wednesday before the Sunday. Any special requests for the use of videos etc should be made as early as possible before the Wednesday.

- when the hymns etc and ideally the order of service are received from the preacher, check the version of The Lord's Prayer to be used and any special requests for things to be included on the screen / in the service
- contact the organist with the hymn numbers
- contact the person putting the hymns etc on the laptop and give them the order of service, hymns etc and any special requests.

# Volunteer Agreement

This is a sample agreement and should be altered according to the specific person involved. The agreement describes the arrangement between the volunteer and the local Methodist Church and should be used alongside the volunteer's work outline.

This Volunteer Agreement is a description of the arrangement between us, the [Name of Church] at [Location of Church], and you [Name of Volunteer] in relation to your voluntary work.

The intention of this agreement is to assure you that we appreciate your volunteering with us and to indicate our commitment to doing the best we can to make your volunteer experience with us a positive and rewarding one.

This agreement is binding in honour only. It is not intended by the parties to be a legally binding agreement nor to create an employment relationship between us but sets out expectations of The Methodist Church and the volunteer.

## Part 1 – The Methodist Church

We commit to the following:

- A full induction and any training necessary for the volunteer role.
- Provide a personal supervisor who will meet with you regularly to discuss your volunteering and any achievements and problems.
- To be treated with respect and in line with the organisation's policies on equal opportunities, health and safety.
- To provide adequate insurance cover for volunteers whilst undertaking voluntary work approved and authorised by us.
- To reimburse the following expenses you incurred in your voluntary work. All expenses must be submitted, with receipts where possible, to [Name Church treasurer and provide email or contact details] within [period]: Please only select the relevant section(s):
  - a. Travel to and from home to (the office) and during your work as necessary
  - b. Meal allowance to a maximum of £(x) with a receipt (to be eligible for lunch allowance you must work around meal times or for a minimum of (x) hours a day.)
  - c. Special clothing, where this is provided by you
  - d. Actual cost of crèche, childminding fees or other dependant costs incurred in order to be available for voluntary work.
